

## **WBIR'S SEASON YOUR SUMMER SWEEPSTAKES OFFICIAL RULES**

1. NO PURCHASE NECESSARY TO ENTER OR TO WIN. A PURCHASE WILL NOT INCREASE YOUR ODDS OF WINNING. SUBJECT TO APPLICABLE FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS. VOID WHERE PROHIBITED.

2. Eligibility. Subject to the additional restrictions below, the "WBIR's Season Your Summer Sweepstakes" (the "Sweepstakes") is open to legal U.S. residents of the state of Tennessee, who are 18 years or older at the time of entry. Employees and contractors of WBIR, TENGA, Inc., and each of their respective affiliated companies, and advertising and promotional agencies, and the immediate family members of, and any persons domiciled with, any such employees or contractors, are not eligible to enter or to win.

Complete the entry form and any other required fields and then submit your entry by clicking on the "SEND" button. Entries limited to only one (1) entry per person per day during the Sweepstakes Period. Your computer must accept cookies, or any successor or similar technology, which may be used for the purpose of entry tracking. Ad blocking software on your computer needs to be disabled, so that it does not interfere with processing your entry. Multiple entrants are not permitted to share the same email address. The authorized account holder of the e-mail address submitted at time of entry will be considered the entrant. An "authorized account holder" shall mean the natural person assigned to such e-mail account by the Internet access provider, online service provider, or other organization responsible for assigning e-mail addresses for the domain associated with such e-mail account. A potential winner may be requested to provide proof that he or she is the authorized account holder of the e-mail address associated with a winning entry.
